



This privacy statement relates to Indulgence' website www.ultimate-indulgence.info and takes effect on 1 January 2013.

Indulgence processes your data exclusively in accordance with the privacy policy below.

General

Indulgence respects the privacy of all users of its website and ensures that all your personal data are treated confidentially.

When you visit our website, various data are collected in order to provide you with an optimal service. This privacy statement explains exactly which data is processed, what is done with your data and what rights you have.

Indulgence guarantees that according to the applicable laws and regulations the correct reports have been made to the Dutch Data Protection Authority (www.cbpweb.nl). These are registered under number 1500031.

Which data are processed by Indulgence?

The data processed by Indulgence consist of three categories, namely information that you enter yourself in various places within the website. This happens among other things when you register as a customer, make an order via the website or contact us via a contact form. This information concerns your identity (name and address, telephone number, e-mail address, gender, date of birth) and data related to the method of payment you have chosen; So-called "traffic data" of visitors to the website. The IP address of your computer is registered and you can check your surfing behavior on the website of Indulgence; Technical data needed to be able to identify you automatically with every loaded page without having to inform us of your identity each time. Such session data is stored in a so-called "cookie", a file that can be stored, read, modified and deleted by a website on your computer. These data are used exclusively to enable the necessary services and operation of our website to be realized and possibly improved. The data are only used internally by us and are not passed on to third parties for commercial purposes.

What does Indulgence do with your data?

The purpose of processing the data is:

Processing your order, payment and delivery to the correct delivery address;
To be able to guarantee the proper functioning of the website and to promote its user-friendliness;

To share your experiences with Indulgence and their products in order to serve you even better;
To be able to make interesting offers, promotions and the like, or to provide you with relevant information or news bulletins.
The personal data are only processed for above-mentioned goals.

Indulgence has no partnerships or special relationships with third parties on the internet.

Security
